GS 81 Commercial Bank Loan Takeover, Augustine Centre, Winnipeg

The General Secretary, Michael Blair, began by noting that there had been concerns about the loan to Augustine Centre for some time. Erik Mathiesen. Executive Officer, Finance, indicated that the Property Fund had sufficient reserves to pay off the loan. The Finance Unit will work with Augustine Centre and the regional council to set up the repayment plan. Shannon McCarthy, Prairie to Pine Regional Council Executive Minister, noted that Augustine was considered to be a viable and valuable outreach ministry, which has a high profile in Winnipeg.

In response to a question it was noted that though the loan will be paid by the national office, the title will transfer to the regional council property trust.
