GS 91 Audited Financial Statements, 2023

Harry Li, Controller, Finance Unit, introduced this proposal. Harry briefly went over some highlights from the 2023 financial statements. He noted the total assets at the end of 2023 have increased by \$17 million: the transfer of Albright Gardens (valued at approximately \$13 million), and the Hope bequest (\$4 million retained by the United Church and \$4 million transferred to the United Church Foundation).
