# GS 104 Authorizing Action for a Principle-Based Approach to Justice Work in the United Church of Canada with Regards to Palestine - Israel

The Moderator invited the General secretary to introduce GS 104 Authorizing Action for a Principle Based Approach to Justice Work in the United Church of Canada with Regards to Palestine - Israel. The General Secretary gave an overview of the report, along with some history, and listed the recommendations as follows.

Recommendations: Given the experience of using the principles and the need for clarity and decision by the General Council, the Sub-Executive of General Council:

Bring to the General Council's attention the dilemma posed by the General Council's two decisions, each of which agree on the value of applying a principle-based approach to justice work in The United Church of Canada but lack clarity as to who will apply the principles concerning a Just Peace in Palestine and Israel; Confirm with the General Council that, in adopting a principle-based approach to justice work, the General Council understood itself to be authorizing the General Secretary, as the senior staff and administrative officer of the General Council (The Manual D.4.2.3d) to act on the principles. Ask the General Council Direct the General Secretary to report to the Executive of General Council how the principles are being applied and the learning;

- a) In preparation for the 2024 annual meeting of the 44th General Council meeting, host a learning session to deepen the Commissioners' understanding of the principles and how they are used.
- b) Provide guidance to the Council on the disposition of proposals GCE 04, CS01, SW09, FSL01, PM02, RC1501, SW02 Peace in Palestine and Israel, and New01 Join the Apartheid Free Communities Movement Proposal received by the Executive of General Council May 10-11, 2024.

There was considerable discussion and time for questions and comments.

As directed by and with the insights of the Executive of the General Council, that the Sub-Executive of General Council:

- Receive the report of the General Secretary and forward it to the 2024 Annual Meeting of the 44th General Council.
- b) Direct the General Secretary, as the senior staff and administrative officer of the General Council (The Manual D.4.2.3d) to continue to report to the Executive of General Council on the advocacy work related to Palestine and Israel and how the principles were applied, and to provide any learning to the Theology Inter-Church Interfaith Committee
- c) Affirm that the application of the Principles allows for the adoption of the strategies of the Boycott, Divestment and Sanction(BDS) Movement and the ability to respond positively to the request of New 01 Join the Apartheid Free Communities Movement (Proposal received by the Executive of General Council May 10-11, 2024), joining the consensus of the international human rights community in recognizing and rejecting Israel's apartheid system of laws and legal procedures towards the Palestinian people and refer proposals GCE 04, CS01, SW09, FSL01, PM02, RC1501, SW02 Peace in Palestine and Israel to the General Secretary as part of the process to guide the church's response.
