INTRODUCTION OF DIVISION OF COMMUNICATION MATERIAL RE 1999 DEFICIT FIGURES

The Sub-Executive was advised that the information with regard to the Division of Communication 1999 deficit and the necessary changes to their 2000 budget was before them to provide accountability rather than for decision. It was felt that although a full accountability report would be coming to the Executive of General Council, in view of the fact that this information would be considered at the Budget Steering Group meeting in March, the Sub-Executive should have this information.

Rebekah Chevalier (Acting General Council Secretary, Division of Communication) took the Sub-Executive through the material, explaining the planned cuts that will be made in each area of Division of Communication to address the 2000 budget shortfall. Steve Adams explained that the reasons for the 1999 deficit were different than the factors that led to the 1998 deficit. Revised rate cards were introduced effective June 1, 1999 which reduced negative variances experienced in Graphics and Print and Audio – Visual production.

The 1999 deficit was primarily the result of an error in the preparation of the Retail and Distribution portion of the Division's budget. The cost of inventory purchases by the Distribution Centre, referred to as National Stock Purchases (NSPs), such as Bibles and UCPH products were not allocated to budgets of the various book rooms. This resulted in an incorrect budgeted "profit" for the book rooms. The error was not detected until September 1999 as the bulk of NSPs are made over the summer months. The same error was made in preparing the 2000 budget and the Division has taken the actions discussed earlier.

The Sub-Executive was also informed that, as of February 2000, the financial aspects of Division of Communication have been moved to the Division of Finance.
