#### UNFINISHED BUSINESS - NOVEMBER 2000 MEETING OF THE EXECUTIVE

#### Resolution #44 – Re-Mandating The Committee On Sexism (GC-2)

This resolution was passed by the 37th General Council authorizing the Executive of the General Council to set in place a re-mandating process for the Committee for Gender Justice.

A question was raised on what the re-mandating role was to be and whether that was appropriate for the Directions Committee to make decisions on. It would seem that the accountability part of this should go to the Directions Committee but not the actual re-mandating process.

That Resolution #44 be referred to the Directions Committee to determine the placement and structure for the work of the Committee for Gender Justice in conjunction with the Committee on Sexism. Carried

#### Petition #112 - Shared Financial Responsibility by Presbyteries for Costs associated with Formal **Hearings and the Decisions arising therefrom (GC-3)**

Petition #112 was received by the 37<sup>th</sup> General Council and referred to the Executive of the General Council to deal with.

That the Sub-Executive of the General Council refer Petition #112 to the Division of Ministry Personnel and Education to develop a proposal and to return it to the Executive of the General Council in April 2001. Carried

<u>First Nations – Recommendations and Resolution from 37<sup>th</sup> General Council (GC-4 – GC4A)</u>
These recommendations and resolution were referred by the 37<sup>th</sup> General Council to the Executive of the General Council for action.

#### Recommendation #1

#### Motion: Jack Spencer/Peter Wesley

2000-11-29-0086

That the Sub-Executive of the General Council take the action in recommendation #1, as follows:

That the 37<sup>th</sup> General Council re-affirm its resolution at the 31<sup>st</sup> General Council to support native Claims to fishing rights by requesting the Federal, and where appropriate, the Provincial Governments to clarify, strengthen and guarantee Indian fishery rights in full consultation with the First Nations people.

And for the Moderator to write a letter to the government and Department of Fisheries encouraging the government to go back to the table and re-negotiate a process that will recognize native inherent rights to their land and its resources.

It was noted that we do not know what negotiations are currently taking place between the government and First Nations people. There are lots of talks going on and we cannot know what is actually being negotiated and what is not.

#### Motion to Amend: Virginia Coleman/Karen Ptolemy-Stam

That the phrase "go back to the table and re-negotiate a process that will" in the second paragraph be deleted so that the paragraph reads as follows:

And for the Moderator to write a letter to the government and Department of Fisheries encouraging the government to recognize native inherent rights to their land and its resources.

#### Motion: Virginia Coleman/Hazel Bigby

That the Sub-Executive of the General Council refer the sections on "Educate the wider Church on native issues" and "Native Ministries need to find creative ways to support their own ministries – Self-determination and empowerment" to the Division of Mission in Canada, the All Native Circle Conference, British Columbia Native ministries and that the section on "Residential schools should not be seen as the basis of our relationships" be referred to the Residential Schools Steering Committee with our support.

That the Sub-Executive of the General Council refer the last part of recommendation #3: "that The United Church of Canada increase its support by ensuring that The United Church of Canada remain active and involved in our First Nations Communities" to the Division of Mission in Canada who will consult with the Conferences to bring back a response for consideration to the meeting of the Executive of the General Council in November 2001.

It was suggested that we need to look at this in a holistic way in order to address the concern. It is important to pull together the people who are involved in doing all these pieces and develop a holistic proposal. A suggestion was made that Division of Mission in Canada look at how to do this.

### Unfinished Petitions from the meeting of the 37<sup>th</sup> General Council (SC-9)

Jim Balfour reported on the work of the Sessional Committee that was set up at the meeting of the Executive of the General Council to deal with unfinished petitions from the meeting of the 37<sup>th</sup> General Council:

#### Petitions #83, #84 and #85 - Articles of Faith (UF-16 - UF-18)

Rationale: These three petitions all raise the question of revisiting the concepts of the 20 Articles of Faith "in light of contemporary theology and language." This is not the first time that such a request has been made. The Theology and Faith Committee has agreed to undertake the drafting of a timely and contextual statement of faith that can stand alongside the Doctrinal Basis of Union (as did the 1940 Statement of Faith).

#### <u>Petition #92 – Compensation for Order of Ministry Personnel when the Pastoral Relationship is</u> Terminated without Cause (UF-19)

**Rationale:** The ninety days notice, referred to in <u>The Manual</u>, is a minimum rather than a maximum compensatory period. It is within the rights of the Pastoral Charge and/or the Presbytery to offer compensation beyond this time frame.

**Rationale:** While not recommending action be taken on this petition, certainly it raises a number of important issues which deserve a further look. Therefore the Sessional committee recommends that the issues raised by Petition #98 be referred to the Division of Communication for their consideration.
