There was considerable discussion on supervision. Keeping in mind, the intent of the original motion of General Council Executive to give this person freedom to work and, at the same time, noting that it was not feasible for the Sub-Executive to supervise in relation to church house policies and procedures, it was agreed that supervision needed to include a staff person.

Concern was also raised around the wording "University and dispute resolution training", noting that we need to have greater understanding stated with the terminology being "University graduation and dispute resolution certification".
