UNIVERSITY OF WINNIPEG FOUNDATION

AND WHEREAS under <u>The University of Winnipeg Act</u>, any "disposition" of the University's endowment funds requires approval of the General Council of The United Church of Canada;

AND WHEREAS the transfer of the endowment funds might be considered a "disposition" under <u>The University of Winnipeg Act;</u>

AND WHEREAS the Foundation's Charter provides that if the Foundation is ever dissolved or wound up, its assets (including endowment funds) will be returned to the University of Winnipeg (if it is still a registered charity at such time);

DESIGNATED LAY MINISTERS

The General Secretary reviewed the recommendations from the Manual Committee that were referred by the Executive of the General Council.

WHEREAS Remit 5A concerning Designated Lay Ministers, authorized by the Thirty-Seventh General Council (2000), was enacted by the Thirty-Eighth General Council (2003);

AND WHEREAS the policies contained in Resolution 9.5 as amended concerning Designated Lay Ministry, and Resolution 9.6 concerning criteria for recognition as a Designated Lay Minister, as adopted by the Thirty-Seventh General Council (2000), need to be reflected in the By-Laws;

AND WHEREAS consultation regarding changes to the By-Laws has taken place with staff of the Faith Formation and Education Unit and the Ministry and Employment Policies and Services Unit;

That the Sub-Executive of the General Council delete section 343 of the By-Laws concerning Lay Pastoral Ministers-in-Training and Lay Pastoral Ministers, and section 345 of the By-Laws concerning Staff Associates, and replace them with the following section:

- **343** Designated Lay Ministers. The Presbytery shall have authority to appoint a person whom it decides to designate as a Designated Lay Minister, to a Pastoral Charge, Mission, Outreach Ministry, or other Presbytery Recognized Ministry.
- (a) Requirements. To be eligible for designation as a Designated Lay Minister, a person must:
 - have been a member of the United Church and active in a Congregation of the United Church, for at least thirty-six (36) months preceding the designation. The question of what constitutes requisite activity in a Congregation for a given person is to be considered and determined by the Session or Church Board or Church Council;

- ii. have received the approval of the Session or Church Board or Church Council of the Congregation of which they are a member, to engage in a period of intentional discernment:
- iii. have engaged in a period of intentional discernment as required by the appropriate General Council unit in accordance with policies approved by the General Council Executive. The period of discernment will be for the purpose of exploring and determining suitability for ministry by considering the person's genuine call to ministry, personal character, motives, faith, and general fitness for ministry in the United Church. The Presbytery will participate in that process of discernment;
- iv. after having completed the period of intentional discernment, be recommended by the Session or Church Board or Church Council for designation as a Designated Lay Minister:
- submit to the Presbytery documents and letters of reference regarding a genuine call to ministry, personal character, motives, education, faith, and general fitness for ministry, and any other relevant information;
- vi. be in essential agreement with the statement of doctrine of the United Church and be willing to abide by the polity of the United Church;
- vii. commit themselves to participating in an appropriate competency based educational program, including educational supervision during the program. The required educational program for the person, and the time period within which it is to be completed, shall be set by the appropriate General Council unit in accordance with policies approved by the General Council Executive. Alternatively, the person may furnish evidence acceptable to the appropriate General Council unit of having completed an equivalent educational program; and
- viii. provide to the Presbytery, at the person's expense, a current police records check.
- (b) Interviews. The applicant for designation may be interviewed by the Conference Interview Board which shall report to the Presbytery. The Presbytery Education and Students Committee shall interview the applicant and make a recommendation regarding designation to the Presbytery.
- (c) Appointment. The Presbytery shall have authority to appoint a person whom it has approved for designation as a Designated Lay Minister. The appointment shall be to a Pastoral Charge with a declared Vacancy, a Mission, an Outreach Ministry, or another Presbytery Recognized Ministry, where the skills, gifts, and education of the person are suited to the needs and gifts of the Pastoral Charge, Mission, Outreach Ministry, or other Presbytery Recognized Ministry. The appointment shall be on the recommendation of the Presbytery Pastoral Relations Committee, after confirmation that the person is "ready for appointment" has been received from the Presbytery Education and Students Committee, and after consultation with the appropriate Conference staff person. Appointments shall be to a specific ministry for a specified term not longer than one (1) year; appointments may be renewed.
- (d) Designation. When:
 - i. the requirements in subsection (a) have been met to the satisfaction of the Presbytery;
 - ii. the person has been approved by the Presbytery for designation as a Designated Lay Minister; and
 - iii. the appointment in subsection (c) has been made, but before the appointment begins; the Presbytery shall designate the person as a Designated Lay Minister.
- (e) Sacraments. A licence to administer the Sacraments on a specific Pastoral Charge for the duration of the appointment may be granted by the Conference to a Designated Lay Minister for whom the Presbytery has decided to make application after having received a request from the Session or Church Board or Church Council.

- (f) Continuance. Continuance as a Designated Lay Minister shall depend upon:
 - i. satisfactory participation in the required educational program;
 - ii. a satisfactory interview by the Presbytery Education and Students Committee following successful completion of the required educational program; and
 - iii. continuance of the Presbytery Appointment.

(g) A person:

- i. whom the Session or Church Board or Church Council has decided not to approve for a period of intentional discernment; or
- ii whom the Session or Church Board or Church Council has decided not to recommend for designation as a designated Lay Minister; or
- iii. whom the Presbytery has decided not to approve for designation as a Designated Lay Minister; or
- iv. whose Presbytery Appointment as a Designated Lay Minister has been terminated by the Presbytery;
- shall not be considered as an applicant for designation as a Designated Lay Minister until a period of at least twelve (12) months has passed from the date of such Decision.
- (h) A Designated Lay Minister is a member of the Presbytery that made the appointment. Their status as a Designated Lay Minister does not extend beyond the jurisdiction of the Presbytery that made the appointment. Except in the case of long-term disability, their membership in the Presbytery as a Designated Lay Minister does not continue after the term of the appointment.

shall have a member of the Presbytery appointed by that Presbytery as the Pastoral Charge Supervisor. The Presbytery shall also have the authority to appoint a Pastoral Charge Supervisor to supervise a Pastoral Charge in any other situation where the Presbytery deems it appropriate.

- **341**(b) Appointment. The Presbytery shall appoint one (1) of its own members as the Pastoral Charge Supervisor to supervise any Pastoral Charge that is without a regularly settled or appointed member of the Order of Ministry or an appointed and that is being served by:
- i. an Ordained or Diaconal Supply;
- ii. a Lay Pastoral Minister-in-Training Designated Lay Minister who has not yet successfully completed the required educational program;
- iii. a Student Supply;
- iv. an Intern Supply; or
- v. a Candidate Supply.

The Presbytery shall also have the authority to appoint a Pastoral Charge Supervisor to supervise a Pastoral Charge in any other situation where the Presbytery deems it appropriate.

389(b)xi. The Committee shall recommend to the Presbytery the appointment of a Pastoral Charge Supervisor for each Pastoral Charge that is without a regularly settled or appointed member of the Order of Ministry or an appointed Lay Pastoral Minister Designated Lay Minister who has successfully completed the required educational program, and that is being served by an Ordained or Diaconal Supply, a Lay Pastoral Minister-in-Training Designated Lay Minister who has not yet successfully completed the required educational program, a Student Supply, an Intern Supply, or a Candidate Supply, or in any other situation where the Presbytery deems the appointment of a Pastoral Charge Supervisor appropriate.

Special meetings shall be called by the Chairperson, a member of the Order of Ministry settled in or appointed to the Pastoral Charge, or a <u>Lay Pastoral Minister Designated Lay Minister</u> appointed to the Pastoral Charge (<u>but only where the Designated Lay Minister is the only Ministry Personnel appointed to the Pastoral Charge and a Pastoral Charge Supervisor has not been appointed by the Presbytery), or, where there is no settled or appointed member of the Order of Ministry or appointed <u>Lay Pastoral Minister</u>, the Pastoral Charge Supervisor, ...</u>

- (c) a <u>Lay Pastoral Minister Designated Lay Minister</u> appointed to the Pastoral Charge (but only where the Designated Lay Minister is the only Ministry Personnel appointed to the Pastoral Charge and a Pastoral Charge Supervisor has not been appointed by the Presbytery); or (d) an appointee of the Presbytery.
- **201** A Quorum for the Church Board shall require that the attendance of:
- (a) a member of the Order of Ministry settled in or appointed to the Pastoral Charge;

- 218 A Quorum for the Church Council shall require that the attendance of:
- (a) a member of the Order of Ministry settled in or appointed to the Pastoral Charge;

- (c) a <u>Lay Pastoral Minister Designated Lay Minister</u> appointed to the Pastoral Charge (<u>but only where the Designated Lay Minister</u> is the only Ministry Personnel appointed to the <u>Pastoral Charge and a Pastoral Charge Supervisor has not been appointed by the Presbytery</u>); or (d) an appointee of the Presbytery.

Interim Recommendations to The Sub-Executive of General Council

1. That the Sub-Executive, through the members previously appointed, continue to "keep a watching brief" of the situation at St. Andrew's - St. Stephen's.

- 2. That it provide this interim report, as "observations," to the Co-Presidents and the Board for their information and consideration.
- That the Sub-Executive and its members intentionally keep the members of this vital college community in their thoughts and prayers, as friends-in-Christ sharing the journey of all who seek a successful resolution of the challenges being addressed by the various parties involved.

Background

In December 2004 the General Council received a request from Saskatchewan Conference "to intervene" in the situation which arose following decisions of the Board of Trustees of the amalgamated colleges taken in October 2003. Members had differing views on how best to go forward. There were serious concerns about a financial crisis, about the loss of Board members including the Interim President and the Board Chair, about misinformation and mistrust, fears about staff layoffs and a loss of capacity, particularly on the part of the St. Andrew's campus, to be the kind of quality theological center it wanted to be.

The General Council Sub-Executive appointed three of its members to meet with the Executive of the Board, to listen and to ensure the functioning of the board including how the General Council could be most supportive. The members were Barbara Rafuse, Jim Jackson and Jim Sinclair.

Conversations were held with Saskatchewan Conference officials, President Laura Thompson and Executive Secretary, Bob Campbell as well as Alberta Northwest Conference Executive Secretary, Lynn Maki. The three Sub-Executive members were also present for a St. Stephen's-St. Andrew's Executive meeting by Conference Call, and later met with Stephen Chambers and Betsy Anderson of the Faith Formation and Education Unit of the General Council Office.

Out of those early meetings, the Sub-Executive determined that an immediate loan of \$120,000 to the college to resolve a breach of trust concern would be helpful.

Subsequently, an invitation was extended for members of the Sub-Executive team to attend the January Executive and Board meetings. Jim Jackson and Jim Sinclair did so.

Observations

The leadership vacancy was a huge concern as the new year loomed.

Response: At the end of December, Randy Boyd, secretary of the Board agreed to take on the role of Chair. At the January meeting, Dr. Earle Sharam, Dean of the St. Stephen's campus, and

Dr. Don Laing, a retired alumnus, closely related to St. Andrew's and a member/Chair of its Board for many years, took on the roles of Interim Co-Presidents until 30 June 2004 when the new President, Dr. Tom Faulkner, takes office.

Financial Concerns:

• A major source of difficulty was the fact that when the Board in October 2003 determined a major need to have a balanced budget in 2005 (July 2004). it indicated that the savings of \$275,000 needed to make this possible would come from the personnel salaries and benefit lines within the budget. This caused a major reaction from staff, students and alumni. By email and at a meeting in Saskatoon in November, the criticism of the Board, both in terms of its content but also in terms of its expression, and lack of recognition of the fiscal exigencies faced by St. Andrew's, led to the resignation of key leaders. All of this resulted in instability within the theological school community itself and within the broader constituency.

Response: At a public forum held in conjunction with the Board meeting, the head of the Finance Committee, Lloyd Baker, stated what he labelled a "tactical error" on his part in the Board's earlier cost-cutting decision. He noted that while the budget needed to be balanced, the Board should not have prescribed how the shortfall was to be made, without consultation with or recommendation from staff. The Board has now determined that it will move towards a balanced budget in 2004-05. It will attempt to fund a transition period and develop strategies both to achieve savings and to raise additional revenue. These decisions were delegated to the Finance Committee to be in place by 31 March 2004.

Having sought legal advice about the potential use of endowment revenue, the Board discovered
that it had an even larger liability than it had earlier thought. Acting on the advice of its auditors,
Coopers-Lybrand, in 1987, the St. Andrew's Board had been using endowment revenue that its
recent legal advice says is in breach of trust in the amount of over \$600,000.

Response: Since the January 12 - 14, 2004 Board Meeting, financing of \$1.2 million dollars is being put in place to resolve the larger breach of trust issue, to repay the United Church loan, and to finance the 2004 operating debt of \$275,000. The Education for Church Leadership Committee of the General Council is extending the present grants to each campus for two more years. They were scheduled to end in December 2005.

The College is now seeking permission of the three prairie Conferences (and has just notified the General Council Office) for a three-year financial campaign. It wishes to launch the effort in September 2004 and to raise \$75,000 in Year 1, \$100,000 in Year 2 and \$125,000 in the third year, 2007. Action re this request has yet to be taken.

Communications / Trust Concerns:

It was clear that for various reasons the situation had been exacerbated because of misinformation, rumours and fear.

<u>Response</u>: Since the Board meeting in January there have been next-day (or even same day) communiqués from the Board Chair to the constituency. The Co-Presidents are actively working at sharing information and meeting with appropriate parties regularly.

Other Concerns:

Amalgamation Processes

The current difficulties come during a yet-to-be completed amalgamation process, between two college staff groups, two academic processes, two cultures, etc. There is a continuing need for intentional effort related to this matter and an excellent Amalgamation Evaluation report, recommendations from which the Board has committed to implementing. However, the reactions of the St. Andrew's community to the need to end on-going deficit budgeting has created significant divisions between faculty colleagues and others on the two campuses.

Governance and Board Development

The 29 person board is a costly undertaking in itself. Its size was identified as problematic by the Amalgamation Evaluation report and the January 2004 Board meeting established a Task group to bring a proposal for reduced size of governance, including the Board, to the May Board meeting.

There was (see above) confusion when the Board took it upon itself to operate at an operational level (directing how the budget was to be balanced) rather than keeping to decision-making that is strategic, policy oriented. There is a need for board development in terms of clarification of role, orientation of new members, etc.

Private Information Circulated

In the Fall, after the October Board meeting, unedited notes made by the secretary of that meeting were taken from a St. Andrew's College computer system hard-drive and circulated widely. This was a source of much confusion and contributed to the breakdown of trust. Steps have been taken to secure such information in the future but requests made to ascertain who removed and distributed the information have been ignored. The serious breach of ethics which it represents has not yet been addressed to determine if disciplinary measures need to be taken.

Relationships Between the Faculty and The Board

When the Board has a strategic plan, and the faculty of one of the campuses is hesitant or refuses to accept that direction, it is seriously problematic. There is a major need for continuing work between these two bodies so that two essential elements of the future success of the amalgamated institution are working in concert.

Potential Effects of Instability on Enrolment

These have not been easy days for the St. Andrew's Campus. It has been a threatening time for the amalgamated institution, including concern over damage to its accreditation from the Association of Theological Schools. Unfortunately, the difficulties are unfolding just as potential students are making their decision about where to go for their theological studies next year. It will be an essential and critical priority for all parties to achieve a stable environment quickly so that a potential drop in enrolment does not threaten the very success which we are confident, can be achieved.
