## **ALTERNATE DISPUTE RESOLUTION**

The Sub-Executive discussed the proposal and received clarification on reporting and confidentiality.

WHEREAS the General Secretary has received a Complaint made to the General Council under the United Church's Dispute Resolution Policy ("Complaint 2004-01").

AND WHEREAS the Dispute Resolution Policy requires the Executive (or Sub-Executive) of the Court receiving the Complaint to appoint a Conflict Resolution Facilitator to contact the parties, conduct a preliminary diagnosis of the Complaint, and report back to the Executive (or Sub-Executive).

- (ii) That he report to the Sub-Executive as per the Dispute Resolution Policy, by May 31, 2004.

#### **DISCONTINUED SERVICE LISTS**

The General Secretary gave an update and background on the work from the Manual Committee.

WHEREAS the General Council Executive, upon referral from the 38<sup>th</sup> General Council, adopted Resolution 84:

AND WHEREAS the adoption of such resolution makes it necessary to amend the By-Laws;

## Motion: Stephen Mabee/Kent Ward

2004-04-07-107

That the Sub-Executive of the General Council amend the By-Laws as follows, in order to reflect the policy adopted by the Executive of the General Council:

"Discontinued Service List" means the record of those former members of the Order of Ministry whose names have been removed from the rolls of Presbytery and Conference by action of the Conference on either a voluntary or disciplinary basis. Persons whose names have been so removed shall not be recognized as Ministry Personnel of the United Church, nor shall they perform the functions of its ordained or diaconal ministry unless specifically stipulated for those on the Discontinued Service List (Voluntary).

<u>"Discontinued Service List (Disciplinary)"</u> means the record of those former members of the Order of Ministry whose names have been removed from the rolls of Presbytery and Conference by action of the Conference as a result of a disciplinary process.

"Discontinued Service List (Voluntary)" means the record of those former members of the Order of Ministry whose names have been removed from the rolls of Presbytery and Conference at the member's initiative and not as a result of a disciplinary process or impending disciplinary process.

032 Re-Admission.

- (a) Application. A person whose name has been placed on the either Discontinued Service List, and who meanwhile has not been received as a minister of another communion, and who desires to be re-admitted, shall make application to the Conference through the Presbytery of which the applicant was last a member. The applicant must clearly indicate to the Presbytery the reasons for requesting re-admission. The application shall include a reaffirmation of the applicant's willingness to conform to the government and usages of the United Church, and to be in essential agreement with the doctrine and polity of the United Church. The applicant, at their own expense shall also provide to the Conference a current police records check, as part of the application for re-admission.
- (d) Presbytery Action. Where the person's name was placed on the Discontinued Service List (Disciplinary), The Presbytery shall examine the applicant's faith and theological stance

before deciding on its recommendation to forward to the Conference. Where the person's name was placed on the Discontinued Service List (Voluntary), the Presbytery shall, if it determines it appropriate, examine the applicant's faith and theological stance before deciding on its recommendation to forward to the Conference.

- (g) Circulation of Name. The appropriate General Council unit shall circulate the applicant's name of an applicant from the Discontinued Service List (Disciplinary) and may circulate the name of an applicant from the Discontinued Service List (Voluntary), and the name of the Presbytery through which the application is being made, to each of the Presbyteries of the United Church. The name of the applicant shall be read at a regular meeting of each Presbytery and included in the minutes of that meeting. Any Presbytery wishing to raise an objection shall present the objection to the Presbytery through which the application is being made. The objection shall be in writing and shall be accompanied by all supporting documentation. Notice that an objection has been raised shall be sent, by the Secretary of the Presbytery raising the objection, to the appropriate General Council unit. The Secretary of the Presbytery through which the application is being made shall acknowledge, in writing, the receipt of the material. The Presbytery shall immediately establish a Commission to consider the objection and to meet with the applicant to discuss the objection. The Presbytery shall decide how the matter will be dealt with and shall send a report to the Presbytery raising the objection and to the appropriate General Council unit.
- 033 Discontinued Service List.
- (a) A person whose name has been placed on the either Discontinued Service List by Decision of the Conference shall not be recognized as Ministry Personnel of the United Church, nor shall they perform the functions of its ordained or diaconal ministry unless specifically stipulated for a person whose name has been placed on the Discontinued Service List (Voluntary).
- (b) A person whose name has been placed on the Discontinued Service List shall not be appointed to a Pastoral Charge, Mission, or Outreach Ministry unless such appointment is required by the Presbytery or the Conference within the process of re-admission.
- Onto Discontinued Service List. The name of a member of the Order of Ministry may be removed from the rolls of Presbytery and Conference and placed on the Discontinued Service List by Decision of the Conference:
- (a) <u>in the case of the Discontinued Service List (Voluntary),</u> at the member's own request when accepted by the Presbytery, <u>and in order to maintain the person's membership in the United Church, the person must become a member of a Congregation:</u>
- (b) in the case of the Discontinued Service list (Disciplinary):
- (i) on the recommendation of the Presbytery for one (1) or more of the reasons indicated in subsection 314(d):
- (c) (ii) on the recommendation of a Formal Hearing Committee pursuant to paragraph 075(k)v.;
- (d) (iii) on the recommendation of a Formal Hearing Committee pursuant to subsection 075(I) together with subsections 363(f) or (g);
- $\frac{\text{(e)}}{\text{or}}$  on the recommendation of the Presbytery pursuant to subsections 363(f) or (g); or
- (f) (v) on the recommendation of the Presbytery as a result of the member having been convicted of a criminal offence.

Such person shall not be recognized as Ministry Personnel of the United Church, nor shall they perform the functions of its ordained or diaconal ministry <u>unless specifically stipulated for a person whose name has been placed on the Discontinued Service List (Voluntary)</u>.

## Amendment: Jim Jackson/Anne-Marie Carmoy

That 367 (a) be amended to remove "and in order to maintain the person's membership in the United Church, the person must become a member of a Congregation".

### Section as amended:

(a) <u>in the case of the Discontinued Service List (Voluntary),</u> at the member's own request when accepted by the Presbytery, <u>and in order to maintain the person's membership in the United Church, the person must become a member of a Congregation</u>:

The Sub-Executive agreed to authorize the Manual Committee to make editorial changes to structure 367 into two paragraphs.

The Moderator thanked the General Secretary and staff for their work. Staff left the call.
