## APPENDIX B

**RECOMMENDATION:** That the Sub-Executive approve an expenditure of up to \$15,000 from the General Council Project Fund to participate in a review to determine if there continues to be a significant purpose and role for The United Church of Canada in the direct delivery of health care services in British Columbia.

### BACKGROUND

For many years the United Church has been involved in the operation of hospitals. At one time there were more than twenty such hospitals across the country, many of these located in areas of need, and for the most part in rural areas. Presently, four of these hospitals remain connected with the United Church of Canada, one at Lamont, Alberta and three in British Columbia at Bella Bella, Bella Coola, and Hazelton.

At Lamont the United Church continues to own the hospital property and the hospital has been incorporated under Alberta regulations. The hospital has a relationship with Alberta and Northwest Conference in terms of mission oversight and technical oversight is carried out by the board of Lamont Hospital.

In British Columbia, United Church Health Services (UCHS), an un-incorporated entity connected with B.C. Conference, provides oversight for the operation of the hospitals as well as medical clinics at the three sites. The United Church (General Council) owns the properties on which these hospitals sit as well as other properties used for staff housing.

For over forty years these United Church hospitals have been funded by provincial government ministries of health. Physician's services are paid for by the provinces through funding arrangements. Other than generous donations by United Church members or organizations, the United Church does not make any financial contribution to the hospitals.

The General Council has maintained an interest in hospitals beginning with its first review ordered by the 1928 General Council. This review recommended the Board of Home Missions and the Women's Missionary Society jointly form a hospitals committee for the oversight of all the medical work of the United Church of Canada. Further reviews in 1955-56, 1984-85 and 1992-93 have been conducted at the direction of either the General Council or the Division of Mission in Canada.

For a number of years, and particularly following the 1994 DMC review, there has been an understanding that as communities became capable of looking after their own health care needs, the United Church would withdraw from operating these hospitals and turn over operations to community boards.

In 2001 the government in British Columbia reorganized health care services creating five large regional boards and dissolving all community hospital boards (including those at Bella Bella, Bella Coola and Hazelton). "Denominational" facilities however were permitted to continue operating with boards in a semi-autonomous manner.

Following this action by the government, the three communities were faced with the prospect of having no input or influence over health care services in their communities. The hospital boards polled the communities informally and there was consensus that the communities would like the United Church to resume operation of the hospitals.

The review to be undertaken in 2004 is then:

*to determine if there continues to be a significant purpose and role for the United Church of Canada in the direct delivery of health care service in British Columbia, and*

if so;

- to clarify and articulate the purpose and role
- to identify the major issues facing the future of this work
- to identify possible future directions for this work
- to choose a course of action to achieve the purpose and role

and if not;

- to identify the major issues involved in withdrawing from direct delivery of health care services;
- to choose a course of action that would allow a withdrawal from direct delivery with a minimum of disruption to the communities involved.

The General Council has an interest in both mission and property in this regard and would benefit from the clarification of its role which this review proposes.

The review is being proposed by, and would be overseen by, B.C. Conference. The review is expected to cost up to \$30,000 with the proposal that B.C. Conference, UCHS and the General Council share in the cost.

The General Council Project Fund is set at a maximum of \$150,000 per year. To date there is one commitment of up to \$25,000 approved by the Sub-Executive in July 2004.
