SALE OF PORTION OF PROPERTY OWNED BY PRAIRIE CHRISTIAN TRAINING CENTRE (PCTC) – CALLING LAKES CENTRE

Whereas PCTC - Calling Lakes Centre owns waterfront property on Fort San Road, Fort San, Saskatchewan:

And whereas PCTC – Calling Lakes Centre has received an offer from an adjoining landowner to purchase a portion of such property approximately 30 (thirty) feet in width, so as to permit the adjoining landowner to build a boathouse;

And whereas the Board of Directors of PCTC – Calling Lakes Centre has approved the sale, which will leave PCTC – Calling Lakes Centre with approximately 100 (one hundred) feet of waterfront property.

And whereas PCTC – Calling Lakes Centre will realize approximately \$28,000 from the sale, which it intends to apply to pay down the outstanding balance of its bank line of credit;

And whereas the by-laws for PCTC – Calling Lakes Centre requires the approval of the supervising Conferences and the General Council for any sale of property owned by PCTC – Calling Lakes Centre; And whereas both Conference of Manitoba and Northwestern Ontario and Saskatchewan Conference, as supervising Conferences, have given their approval to the sale of this property;

EXECUTIVE OF THE GENERAL COUNCIL – LOCATION FOR APRIL 2005

The Moderator updated the Sub-Executive on the proposal for the Executive of the General Council to meet in Vancouver, B.C. for its April 2005 meeting. It was noted that the meeting would be extended one extra day and that the extra cost for this meeting would be approximately \$50,000. The General Council Project Fund is one option for these extra costs.

Discussion and concerns were expressed regarding the extra costs for this meeting versus the benefits. It was noted that this extra amount would be distributed over the triennium as we move into a 3 year budget cycle. Meeting in both the east and the west was also noted as an important benefit for the Executive as they experience the life of the church across the regions.

Discussion included suggestions on experiences that would be helpful both for the Executive and for the people in B.C. Conference. It was noted that Vancouver is in close proximity to 3 presbyteries plus Pemberton-Whistler that will be faced with ramifications from the Olympic games. Other opportunities include visiting congregations in the lower mainland where people arriving from Korea is just one factor that is contributing to the changing nature of these congregations.

Marion Pardy left the call.

One of the goals for the Executive during each triennium is to experience maximum exposure to local people so that the people can see the GCE in operation and the GCE can meet the people where they

live. Seeing and understanding the concerns in the regions is a valuable experience and opportunity different from just hearing about concerns.

There was a suggestion that a parallel process for staff (such as staff retreat) take place so that staff also experience the regions.

APPENDIX A

TO: General Council Sub-executive

December 17, 2004

RE: Tomisato Property, Japan

BACKGROUND

The United Church of Canada, along with several US Mission Boards, has an interest in several properties in Japan. Legal title to the properties and related funds is held by a Japanese corporation called the Zai Nippon Interboard Senkyoshi Shadan (Shadan). The Board of Directors of the Shadan is made up of mission personnel from the founding boards (including the United Church of Canada). The properties were originally purchased by churches to support mission in Japan, particularly the housing of mission personnel.

The United Church of Canada has an interest in 4 properties:

Tomisato (a manse in bad repair and currently vacant)

Nayoro (a manse in good repair and currently used as housing for UCC personnel)

Denenchofu (a 3 plex apartment building. 1 apartment is used by UCC personnel, 2 are rented to other mission board personnel)

Kobe (a single dwelling home rebuilt by the UCC following an earthquake in 1996)

In 1977 the Division of World Outreach, at its AGM, affirmed the following principles to guide decision making on the properties:

That the Division of World Outreach re-affirm to JNAC and the Kyodan (United Church of Christ in Japan) its ultimate goal of transferring missionary residence property in Japan to the Kyodan, when the latter are in a position to accept responsibility to provide housing for missionaries...(77-247).

In 1999, the Division of World Outreach Executive approved in principle that funds from the disposition of properties in Japan should be used as follows:

- 1. Personnel related needs
- 2. Mission needs in Japan as articulated by Japan partners
- 3. Needs for ongoing mission work outside of Japan
- 4. Need to supplement the fund for property maintenance and overseas personnel support.

A supplemental note from the Asia/Pacific Area Committee to the DWO Executive identified the following matters to be taken into account:

Past practice that all properties formerly owned by the United Church of Canada overseas were turned over to national properties.

The intent of donors who made possible the purchase of properties in Japan through bequests, estates etc was that those property assets be used for mission in Japan. The practice of the Division has always been to respect the intent of donors who made such acquisitions possible.

The value of properties is not simply reflected in the dollar value but has value in terms of ongoing and future mission with Japanese partners. The theological and missiological implications of property use but be equally considered.

PROPOSAL

At its meeting on November 20, 2004, the JGER Unit Committee approved the following motion:

That the JGER Unit Committee recommends to the Sub-Executive of the General Council the proposal for the sale of the property in Tomisato, Japan to the Tomisato United Church in Japan for Y6,000,000. That the funds from the sale of the property be put in the trust account held to

offset the maintenance costs of the other properties and to support UCC overseas personnel and mission needs in Japan.

The congregation plans to build a new church on the site. The national church (Kyodan) has confirmed that this meets their critical priority of evangelisation. The church hopes that, in addition to providing a worship place, they can offer community outreach programs such as a migrant ministry or Day Care.

The church has requested a sale price below market value (Y 6,000,000 against an appraised value of Y 15,000,000 - Y 17,000,000). There are zoning and environmental restrictions on the property which limit its commercial sale value. As well the house on the property is in significant disrepair. The Kyodan has acknowledged that if the United Church of Canada agrees to the sale the difference between the sale and appraised values would be considered a contribution to the life and mission of the Japanese church.

that the Sub-Executive of the General Council authorise the sale of the Tamisato property in Tamisato, Japan to the Tamisato United Church in Japan for Y6,000,000, and that the funds from the sale of the property be placed in the trust account held to offset the maintenance costs of the other properties and to support UCC overseas personnel and mission needs in Japan.

APPENDIX C

Whereas direct provision of health services through United Church Hospitals in British Columbia has been vested with BC Conference through United Church Health Services (UCHS)

Whereas BC Conference initiated a consultative review to:

- (1) determine if there continues to be a significant purpose and role for the United Church of Canada in the direct delivery of health services in BC, and, if so, to:
- (2) clarify the purpose and role of UCHS in BC, identify major issues and future directions, identify major issues for BC Conference and the UCC with respect to the future of this work, and make recommendations

Whereas the General Council Executive (through the Sub-executive) participated financially in the review through the GC Project Fund (\$15,000)¹

Whereas part 1 of this work is complete and the review team in its report to BC Conference has concluded that, with respect to the first item (is there a purpose and role for the UC in this work?):

"The United Church has a political responsibility.

- The long and honourable history of the UCHS creates a sense of pride and trust by the communities and provides a sense of stability in these communities that are currently facing many changes and challenges, including an extremely high level of unemployment and isolation.
- 2. By virtue of being a denomination faith-based health service, with church owned facilities, each of the UCHS communities has a local hospital board which provides a degree of selfgovernance, community representation and autonomy.
- An appreciated "centre of excellence in rural, remote and First Nations health" culture has 3. been created - one that has potential for further development and basis for recruitment, retention and capacity building.
- The UCHS presence has helped provide leverage for outside funding from local, 4. provincial and federal agencies and NGO's. This has made it possible for the hospitals and clinics to initiate, promote and integrate many community outreach programs
- 5. UCHS facilities and personnel constitute a major community asset – as a major employer, in attraction and retention of new citizens, and supporting, leading and participating in community activities.
- UC hospitals have a reputation and record of sound fiscal management that is not consistently found elsewhere in the now regionalized system and are much more advanced in their integration of First Nations health needs.

The United Church has moral/spiritual leadership responsibilities.

- UCHS facilities are providing high-quality, accessible, culturally sensitive primary and secondary health care. A holisitic approach to health care includes, when relevant or requested, traditions and practices of First Nations people.
- 2. A common vision and commitment to self-giving service that transcends monetary considerations has historically been created by the strong Christian leadership and directed recruitment policies of the UCHS.
- Long-term recognition of excellent educational potential has resulted in the assignment of responsibility for training future rural health care professionals.

The United Church has communication and oversight responsibilities for urgent matters. The UCHS review and the review team's site visits did cause considerable anxiety among various stakeholders, including staff, patients, First Nations organizations and the community in general.

Different perspectives on the reason for the review and the underlying intent of the United Church were voiced, including fear that if the United Church "pulled out" there would undoubtedly be

reductions in types and amounts of health care services in each of the communities and a lack of community control."²

Whereas the review team recommends that:

"RECOMMENDATIONS:

United Church of Canada Involvement

Based on the Review Team findings there continues to be a significant purpose and role for the United Church of Canada in the direct delivery of health services in BC.

Therefore it is recommended the UCC continue to be involved.

Urgent Issues

There are issues that require urgent and immediate attention.

Therefore it is recommended that:

- 1. The decision about the United Church involvement in the direct delivery of health care services be made and communicated to the three communities and health authorities before year-end (i.e. December 31, 2004).
- 2. If such a decision cannot be made in this timeframe:
- a. That a firm date for such a decision be set quickly and communicated to the communities and health authorities; and
- An interim plan for continuing present operations be established and communicated prior to yearend.
 - 3. Accountability and staffing issues be addressed by providing for an interim Director and confirming the employment status of those working in the Director's office and those who positions rely on the clinics and their previous funding.
 - 4. Those who organized the on-site review process arrangements be thanked.
 - 5. The communities, through the churches, hospital boards and clinic directors be acknowledged and thanked for their participation."³

Whereas BC Conference through the authority delegated to the Conference Executive Secretary concurs with the findings and recommendations contained in part 1 of the report

Whereas work will continue with part 2 (clarifying role and future directions)

Be it resolved that the General Council Sub-executive affirm the UCC's continuing involvement in health care services in BC through BC Conference and UCHS, and encourage continuation of work on the review process.
