## Seal Document of The United Church of Canada

## Motion: Stephen Mabee/Jim Jackson

2006-02-28-344

The Second General Council, meeting in June 1926, adopted By-Law Number 126 of The United Church of Canada with respect to the Seal of The United Church of Canada.

By due and valid process, By-Law 126 has since been renumbered to become Section 515 of *The Manual* and has been amended by the proper Courts of the Church to read as follows:

There shall be an Official Seal for The United Church of Canada. When it is required to affix the seal to any document, except where otherwise provided by any Act respecting The United Church of Canada, it shall be attested by the signatures of any two of the following officers: The Moderator, the General Secretary of the General Council, the General Council Ministers, and the Executive Officer, Finance (any one of whom shall for this purpose be entitled to temporary custody of the Seal and to affix the same), or by any one thereof, together with any one of six other persons to be appointed by the Executive of the General Council.

NOW, this is to certify that the following are the persons above-mentioned who are authorized to affix the Seal of the Church and to attest it to wit:

## **Background:**

The Executive Secretary of London Conference is responsible for the smooth functioning of the Conference Office, supervising the staff team and supporting the President of London Conference. He/She is also responsible for the communication between General Council and London Conference and its Presbyteries. The Executive Secretary is accountable to the Conference through the Conference Executive and the Conference Staff Support Committee, and to the General Council through the General Council Minister, Regional Relations.

This position will be vacant due to the retirement of Peter Scott.

London Conference's Executive approved the composition of the selection committee: Cheryl-Ann Stadelbauer-Sampa (chair), Sheryle Steadman, Dave Williams, Fern Patterson, Anne Beattie-Stokes, Jim Evans, and Bob Estey. Carol Hancock participated as G.C.M., Regional Relations.

The selection committee interviewed the short-listed candidates on February 16<sup>th</sup> and 17<sup>th</sup> and were delighted by the strength of the field. The committee came to strong consensus on its recommendation for the position. Our review of references confirmed our decision. On Monday, February 27<sup>th</sup>, the chair of the committee shared our recommendation with the London Conference Executive by telephone conference and has reported to me that our work was enthusiastically supported.

An offer of employment, subject to appointment by the Sub-Executive, is acceptable to the candidate.
