CONSTITUTING THE MEETING

The Moderator constituted the meeting with the following words:

Minutes of the Sub-Executive of the General Council

Designated Ministry (Proposal MEPS 7)

Cynthia Gunn gave an overview and background to this proposal including the concern that the remit authorized regarding Designated Lay Ministry included all lay ministers whether congregational or presbytery designated ministers as members of presbytery.

Discussion continued including different understandings about what the presbytery voted on. It was also noted that the work has continued to evolve since the remit.

It was agreed to refer this proposal (MEPS 7) to the next meeting of the Sub-Executive of the General Council.

Retirement (Proposal MEPS 10)

It was noted that we do have to comply with the law regardless what the by-laws state.

The Sub-Executive of the General Council recommends that *The Manual* be amended to comply with legislation which prohibits discrimination on the basis of age and specifically prohibits mandatory retirement.

That the Sub-Executive of the General Council authorize the General Secretary to amend the Human Resources Policy Manual to comply with the legislation which prohibits discrimination on the basis of age.

That the Sub-Executive of the General Council direct the General Secretary to communicate these changes regarding mandatory retirement to all Conferences, Presbyteries/Districts and Pastoral Charges.

Police Records Check (Proposal GS 10)

That the General Secretary seek the approval of the 39th General Council 2006 to amend *The Manual* to implement this policy.

Faith and Order Sessional Committee

Staff as Corresponding Members (Proposal GPBP 9)

Members from the Sessional Committee reviewed the discussion that took place in the Sessional Committee on the following proposal.

That the membership of the Executive of the General Council be changed so that staff of the General Council (currently named as corresponding members) be changed to “Staff Resource” to the General Council, the Executive of the General Council, and the Sub-Executive of the General Council. This reflects the clarity of role for staff and elected members in these courts. This change in role affects all staff of the General Council: General Council Ministers, Conference Executive Secretaries/Speaker, Executive Ministers/Executive Officers, and Chief Archivist. The General Secretary may direct staff to attend meetings in the role of staff resource.

Roles and Relationships – Elected Members and Staff (Proposal GPBP 8)

Review and revise the terms of reference for the four permanent committees to be consistent with Sections 601, 602, 603 and 604 of *The Manual* and

Recommend to the Manual Committee that Sections 601, 602, 603 and 604 of *The Manual* be moved in *The Manual* to the section on the Executive of the General Council.

Enhanced Role for the General Council and Greater Communication between General Council Meetings (Proposal GPBP 6)

Discussion on this proposal noted that this is only a list of suggested actions and that there may be other ideas or that these actions are not practical or workable.

That the Executive of the General Council endorse more effective communication between the Moderator and the General Council commissioners during the triennium.

That the Executive of the General Council direct the General Secretary to assist in the implementation.

That the following items be referred to the General Secretary for consideration:

1. Following Executive of the General Council meetings, the General Secretary provides brief summaries of Executive decisions and actions, and highlights of the meeting to General Council Commissioners. This could be in the form of a newsletter to Commissioners and not a duplication of articles in *The Observer*.

2. The Moderator and General Secretary provide an Annual Report to the General Council Commissioners in recognition of the role and status of the General Council.
3. Provision be made for surveying the Commissioners on their views on particular subjects to help guide the work of the Executive and General Council Office.
4. Commissioners be identified and listed in directories of their respective courts (Conferences, Presbyteries and Pastoral Charges) as an aid to greater interaction and discussion of church issues.
5. Consideration be given to regional meetings of Commissioners to maintain a sense of identity during a triennium; these could be linked with other events or meetings scheduled by a Conference or the General Council Office.
6. Commissioners of a General Council be encouraged to maintain contact with each other to create informal networks for sharing experiences and ideas, continue the learning from a General Council, and promote friendships.
7. Commissioners be encouraged to serve on committees and task groups of the Executive of the General Council
