Whereas it is deemed expedient and in the best interests of The United Church of Canada (the "Guarantor") that it lend assistance to SYMONS VALLEY UNITED CHURCH (the "Customer") in connection with its borrowings, both present and future, from ROYAL BANK OF CANADA (the "Bank"),

The Sub-Executive of the General Council resolves that:

- 1. The Guarantor guarantee payment to the Bank of all present and future debts and liabilities, including interest due at any time by the Customer to the Bank; provided that the liability of the Guarantor shall be limited to the sum of Three Million Ninety-Five Thousand AND 00/100 Dollars (\$3,095,000.00) together with interest from the date of demand for payment at the Prime Interest Rate of the Bank plus 0.750 per cent per annum;
 - For the purposes hereof (where applicable), Prime Interest Rate means the annual rate of interest announced from time to time by the Bank as a reference rate then in effect for determining interest rates on Canadian Dollar commercial loans in Canada.
- 2. That the Guarantor further secure the Bank by postponing all debts and claims, present and future, of the Guarantor against the Customer to the debts and claims of the Bank against the Customer.
- 3. That the Guarantee and Postponement of Claim on the form attached, be and is hereby approved as containing a correct statement of the terms and conditions upon which the said

guarantee and postponement are to be made and that the said Guarantee/Suretyship and Postponement of Claim be duly executed for and in the name of the Guarantor (under the corporate seal where required) by Ian Fraser, General Council Minister and Ron Olsen, Executive Officer-Financial Services, with such alterations, additions, amendments and deletions as they may approve; and that the Guarantee/Suretyship and Postponement of Claim so executed is the Guarantee and Postponement of Claim authorized by this resolution.

- 4. That for the purpose of securing this Guarantee, or any present or future debts or liabilities, including interest due at any time, by the Customer to the Bank, the Guarantor shall provide to the Bank any security, including accommodation endorsements, which the Bank may request, and that for such purpose the officers of the Guarantor mentioned in paragraph 3 hereof be and they are hereby empowered for and on behalf of the Guarantor to provide such security and to execute such further documents as the Bank may require.
- 5. That a copy of this Resolution, certified by the Secretary of the Guarantor (under the corporate seal where required) be given to the Branch of the Bank where the customer has Its account, and that the designation of the officers under Section 3 of this Resolution shall be binding upon the Guarantor until a Resolution, certified by the Secretary of the Guarantor, charging the officers is received by that branch of the Bank.

Appendix A

Background

The Executive Minister: Ethnic and Intercultural Ministries directs the work of the Ethnic Ministries Unit and is accountable to the General Council Minister, Programs for Mission and Ministry. A primary focus of Ethnic Ministries has been framed in the General Council's approval of a "Transformative Vision for the United Church of Canada" and the action of the General Council Executive in identifying interculturalism as a key priority for the church. The Executive Minister therefore is expected to provide important leadership in achieving this vision.

This position is vacant due to the end of the interim work of George Takashima.

The Executive of the General Council approved the composition of the selection committee: Anne-Marie Carmoy, Carmen Lansdowne, Diane Dwarka, Jong Bok Kim, Danielle James, and Bruce Gregersen. Susan Legault, HR Manager provided staff support to the committee. With the agreement of the committee, Adele Halliday, member of Ethnic Ministries staff and acting Executive Minister of the Unit provided corresponding support.

The selection committee interviewed the short-listed candidates on September 6th and 7th and was deeply impressed by the strength of the field. The committee came to consensus on its recommendation for the position. A review of references confirmed the decision.

An offer of employment, subject to appointment by the Sub-Executive, is acceptable to the candidate.

Appendix B

RE: Suggestion to boost 2007 M & S givings.

The Mission and Service goal for 2007 in our financial plan is \$30,200,000.

In response to adopting our plans toward 2010, and in particular the planned reduction in 2009 in grants to Global Partners and local partners (Mission Support Grants) some considerable discussion has occurred in many courts of the church.

Arising from these discussions has come the suggestion that we conduct a fundraising drive, special appeal or some other method to generate additional givings to avoid the planned reductions.

Establishing a separate appeal at the same time we are about to launch the United for Peace campaign might be problematic and may well have the effect of taking away from the Mission and Service Fund. While considering this proposal, we need to support the concept of a unified fund as the way that the church does God's mission and we must also be mindful of the priority setting process within our church.

However, one possibility might be to challenge the church to exceed the 2007 Mission and Service goal with the commitment that anything in excess of the goal would be earmarked specifically to diminish the planned 2009 grant reductions.

The handling of surpluses or deficits is governed by policy of the Executive of the General Council (2004-04-23-124) which regulates the Mission and Service Operating Fund. Implementing this suggestion would require deviation from this policy and therefore the approval of the Executive.

Should we wish to pursue this suggestion I could request the Permanent Committee on Finance, meeting Friday October, 21, 2007 to consider a proposal along the following lines and make their recommendations to the Executive meeting in November:

That givings to the Mission and Service Fund for 2007 in excess of \$30,200,000 be set aside to reduce, equally, the planned 2009 reductions in grants to Global Partners and Mission Support Grants.

Should we wish to pursue this suggestion I could request the Permanent Committee on Finance, meeting Friday October, 21, 2007 to consider a proposal along the following lines and make their recommendations to the Executive meeting in November:
