# **Dunbarton-Fairport United Church Transfer**

Whereas Dunbarton-Fairport Pastoral Charge is presently within the jurisdiction of Toronto Scarborough Presbytery within Toronto Conference, and it is desirable that it be transferred to Oshawa Presbytery within Bay of Quinte Conference;

# Naramata Centre's Operating Line of Credit

Discussion took place and the Sub-Executive urged Naramata Centre to bring their bylaws in compliance with Section 429 of *The Manual* for Category 1: The United Church of Canada Incorporated Ministries.

Whereas the Board of Directors of Naramata Centre by letter dated February 2008 have requested approval from the Executive of the General Council for an increase in Naramata Centre's line of credit from \$175,000 to \$2,000,000 all of which will be secured by a mortgage on the property of Naramata Centre;

And whereas the line of credit increase is subject to the condition that \$500,000 is for operating expenses and \$1.5 million is for capital expenses;

And whereas the purpose of the increase of the loan is to fund higher operating costs and additional capital fund requirements, all as more particularly outlined in the letter dated February 11, 2008 from Naramata Centre to British Columbia Conference;

And whereas the bylaws for Naramata Centre require the approval of B.C. Conference and the General Council for a mortgage by Naramata Centre for a term of 5 years or more;

And whereas British Columbia Conference has approved the request for the increase in the line of credit;

And whereas the approval of the membership of the Centre will be sought at an extraordinary general meeting on April 4, 2008;

## **Motion: Nora Sanders/Dwaine Dornan**

That the Sub-Executive of the General Council approve the request of the Naramata Centre for an increase in its line of credit amount from \$175,000 to \$2,000,000, secured by a mortgage on the assets of Naramata Centre subject to the condition that \$500,000 of that amount is for operating expenses and \$1,500,000 is for capital expenses.
