## **Indemnity Policy**

That the Sub-Executive of the General Council:

Adopt the policy that each and every officer, member, employee or volunteer who is authorized or directed by the General Council, Conferences or Presbyteries to carry out a responsibility on behalf of The United Church of Canada (the "United Church"), and who has undertaken such responsibility on behalf of the United Church, and their respective heirs and personal representatives, shall from time to time be indemnified and saved harmless out of the funds of the United Church from and against:

i all costs, charges and expenses whatsoever that such person sustains or incurs in or about any action, suit or proceeding that is brought, commenced or prosecuted against such person in the execution of such responsibility; and

ii all other costs, charges and expenses that such person sustains or incurs in or about or in relation to the affairs of the United Church, except such costs, charges or expenses as are occasioned by such person's wilful neglect or default;

provided that no indemnification shall be made by the United Church for any costs, charges or expenses that arise in any way out of the failure of the person seeking indemnity to act honestly and in good faith in the execution of such responsibility.

# Appendix A

# Sale of Alcove Property, Quebec Background

- In 1959, Mary Edna Pritchard donated a parcel of land for the Alcove United Church with the understanding that if the United Church permanently discontinued holding services at that location, the property would revert back to Mary Edna Pritchard or her Estate.
- The property is legally described as Part of lot Two "C: (Pt lot 2C), Range Five (R5), Township of Wakefield, Gatineau Registry Office and municipally known as 57 Chemin River, La Pache, Quebec.
- Ottawa Presbytery voted to disband the Alcove congregation in 2004.
- Title to the property is now held by The United Church of Canada.
- In keeping with the terms of the 1959 deed, an agreement has been reached with the Pritchard family for the property to be sold to David Pritchard for a sale price of \$75,000, with the net proceeds to be divided 50% to the Pritchard Estate and 50% to Wakefield Pastoral Charge as a gift of the Pritchard Estate.
- Under Quebec law, all sale documentation must be signed by authorized signing officers or their representative under power of attorney in the presence of a Notary of the Province of Ouebec.
- Rosemary Lambie, Conference Executive Secretary of the Ottawa and Montreal Conference Office has agreed to be the representative of The United Church of Canada under power of attorney by the authorized signing officers, in order to execute all required documentation in to complete the sale of the property in the presence of a Notary of the Province of Quebec.
