Title: Extension of "Sharing Bread": Enhancing Our Response to the Economic Crisis Origin: General Secretary, General Council

Background

At its March meeting, the Executive of the General Council approved a proposal to make available \$500,000 from the Emergent Work budget line as a crisis response fund to address the economic crisis gripping Canada and the world. The proposal was approved in principle, with direction to the General Secretary to take into account the discussion in Sessional Committee in reworking the process and including a component for global work.

The "Sharing Bread" program that is being implemented makes available

- \$210,000 for distribution in Canada
- \$210,000 for distribution through global partners of the United Church
- \$80,000 to provide ministry staff educational opportunities related to responding to this crisis

Since the news of the establishment of this fund was released on May 26, the response has been overwhelming. In just a few weeks, funds earmarked for projects in Canada have been exhausted, reflecting both the depth of the economic crisis and the abundance of worthy ministries that are seeking to promote justice during this difficult time. More than 30 programs are already benefiting, including summer camps, rent and food banks, and a micro credit program.

Currently, there are about 25 applications in our hands that cannot be funded unless additional money is allocated. The website now indicates that no further applications can be considered. It would cost about \$150,000 to cover those applications already received. The alternative is to write to the proponents of these worthy projects and tell them there is no more funding available.

The funding for the other elements of "Sharing Bread" is still in the process of being implemented. By their nature, these will take a little longer, but the funds allocated for the global component and the ministry personnel training are expected to be fully expended. On the international side, staff members in the Justice, Global and Ecumenical Relations unit are inviting global partners to submit applications that will be considered by Nov. 30. Plans are underway for the formation of "facilitated learning communities" for ministry personnel who are facing new demands because of the economic crisis.

The funding for "Sharing Bread" comes from the \$1 million allocated in the 2009 budget for emergent work. So far, \$750,000 has been allocated: \$500,000 to "Sharing Bread," and \$250,000 to the Aboriginal Circle and Council. That leaves \$250,000, and it is recommended that the \$150,000 requested for additional funding for "Sharing Bread" come from this pot of money. This would support significant and worthwhile work in congregations and community ministries struggling to respond to the economic downturn.
