# Retired Designated Lay Ministers; License to Administer Sacraments

A concern was raised concerning the naming of Designated Lay Ministers for a specific purpose and whether this would create inequity regarding those not named. The General Secretary, General Council will raise this concern and ask for the advice of the Permanent Committee on Ministry and Employment Policies and Services.

## Motion: Nora Sanders/Paul Stott

2009-12-10-029

That the Sub-Executive of the General Council amend the By-Laws as follows, to implement the policy in Proposal GCE 38 [GC ANW 13], adopted by the Executive of the General Council upon referral by the 40th General Council 2009:

343 Designated Lay Ministers. ...

. . .

- (e) Sacraments. A licence to administer the sacraments on a specific Pastoral Charge for the duration of the appointment may be granted by the Conference to a Designated Lay Minister for whom the Presbytery has decided to make application after having received a request from the Session or Church Board or Church Council.
- (f) In the case of a Designated Lay Minister who has been recognized by the Conference, a licence to administer the sacraments may, at the discretion of the Conference, permit the Designated Lay Minister to administer the sacraments within the jurisdiction of the Presbytery to which the Designated Lay Minister is accountable.
- (g) [new] Sacraments. A licence to administer the sacraments within the jurisdiction of the Presbytery, in cooperation with the Session or Church Board or Church Council and under the oversight of the Presbytery, may be granted by the Conference to a lay member of the United Church who at the time of their retirement was serving as a Designated Lay Minister who had been recognized by the Presbytery and for whom the Presbytery has decided to make application.

**427.1** Licence to Administer Sacraments. It shall be the duty of the Conference:

- (a) ...; and
- (b) to consider an application from a Presbytery to grant a licence to a Designated Lay Minister, Candidate Supply, Intern Supply, Student Intern, Student Supply, or Diaconal Supply in a Presbytery Appointment to administer the sacraments on a specific Pastoral Charge for the duration of their appointment.
- (c) In the case of a Designated Lay Minister who has been recognized by the Conference, a licence to administer the sacraments may, at the discretion of the Conference, permit the Designated Lay Minister to administer the sacraments within the jurisdiction of the Presbytery to which the Designated Lay Minister is accountable.
- (d) [new] to consider an application from a Presbytery to grant a licence to a lay member of the United Church who at the time of their retirement was serving as a Designated Lay Minister who had been recognized by the Presbytery to administer the sacraments within the jurisdiction of the Presbytery, in cooperation with the Session or Church Board or Church Council and under the oversight of the Presbytery.

## **Motion: Paul Stott/Heather Burton**

That the Sub-Executive of the General Council direct the General Secretary, General Council to prepare a planning document for consideration and decision by the Executive of the General Council at its meeting in May, 2010 that will:

- a. be premised on the belief that we live in God's abundance;
- b. be guided by the themes named by the 40th General Council 2009 and also informed by the Call to Purpose (GC39), and the Priorities of GCE 39
- c. respect the financial projections provided by the Permanent Committee on Finance
- d. work within the existing polity of the church
- e. set out, with rationale as well as cost, program, and structural implications, three options reflecting three distinctly alternative approaches for a plan for 2011-2013:
  - Current configuration with reductions shared broadly and equitably
  - Radical reimagining of roles and relationships among the General Council Office and of the Courts of the Church to achieve reductions and lift up work in new ways
  - Reductions and "rainy day" spending (cut deeper than required and using savings as well as additional draws from reserves for innovative work)
