Constitution of the Meeting

The Moderator opened the meeting with a reflection on Epiphany. The Moderator prayed for the people of Haiti and Sudan, and all members of the Sub-Executive who were not present at this meeting.

The Moderator constituted the meeting with the following words:

Transfer and Settlement Incentives

Nora introduced the Transfer and Settlement Incentives proposal. Prospective candidates for ordination/commissioning in 2011 must indicate their intention to apply for Transfer and Settlement by February 1, 2011. In the third paragraph of page 3 of the background of the proposal, the date should be amended to read 2011 instead of 2010. Option 3 is not limited to the first move after settlement. The Moderator expressed deep gratitude for the work done to prepare this motion.

The Permanent Committee on Ministry and Employment Policies and Services proposes that the Sub-Executive of the General Council adopt the following policy:

In recognition of the willingness of a candidate for ordination or commissioning to serve the church anywhere Transfer and Settlement Committee places them, that candidates be given the opportunity to choose one of the following four options no later than June 15th of the year of Settlement:

Option 1—That two extra weeks of vacation each of three years while on the settlement charge be provided to individuals choosing Transfer & Settlement and that the General Council provide the pastoral charge with \$1500 per year to assist with pulpit supply and salary costs.

Option 2—That the General Council provide a cash bonus of \$1500 (taxable) each of three years while on the settlement charge to individuals choosing Transfer and Settlement.

Option 3—That individuals choosing Transfer and Settlement be allowed to accrue a credit of \$1500 each of three years while on the settlement charge to be applied towards a subsequent move.

Option 4—That individuals choosing Transfer and Settlement be offered a premium relocation package worth up to \$4500 (over and above the physical move of household goods) which would provide a menu of choices to ease the burden of relocating to the settlement charge. This program includes a client agent to support the entire relocation experience, with options that would include: a pre-move trip for house/apartment hunting; return trips "home"; guaranteed home sale; real estate costs; partner assistance (job finding, etc); premium household goods move (full pack), and many other service options.

Nora Sanders introduced the proposal to appoint David Armour as the new Director of Philanthropy. He is currently CEO of the Canadian Olympic Foundation and has served on various other non-profit organizations. His start date will be February 14, 2011.

Response to Motions from Bay of Quinte Conference Annual Meeting May 2010

Paul Stott introduced the motion. Bruce Hutchinson declared an interest in this motion and thanked Paul Stott for this work and suggested three amendments. After lengthy discussion the motion was amended to read as follows:

Motion: Paul Stott/Louise Rogers

That the Sub-Executive of the General Council, in response to the request of the Bay of Quinte Conference Annual meeting, found in motion 86th.10.25 and adopted May 29, 2010:

- 1. acknowledge with sympathy the pain and uncertainty experienced by Bay of Quinte Conference and all the parties involved in the resolution of the personnel issues of April 2010 and following;
- 2. deny the request of Bay of Quinte Conference to appoint an investigator "to investigate the terms of reference for all those who are responsible for oversight and supervision of Conference Staff", in light of investigative work already undertaken and actions currently underway;
- 3. affirm that the General Secretary, General Council appropriately exercised her role in this matter:
- 4. recognize that greater role clarity is necessary with respect to position descriptions in light of the nature of the church's conciliar governance structure;
- 5. direct the General Secretary, General Council to consult with the Permanent Committee on Governance and Agenda with respect to the matter of existing and evolving understandings of conciliar governance,
 - a. in carrying out the direction of the Executive of General Council to clarify the roles of Conference Executive Secretaries/Speaker and develop a standard framework for those positions; and in
 - b. developing the revised job description for the position of General Council Officer of Conciliar Relations that is to include clear guidelines for oversight of the Conference Executive Secretaries /Speaker; and
- 6. Direct the General Secretary, General Council to discuss the "Investigators' Report Bay of Quinte, April 2010 (Ralph Schmidt and Harry Brown)" with the Interim Executive Secretary, and the President of Bay of Quinte Conference, so that learnings from it can be reflected in the ongoing management of the Conference office.
