# Approval of extension of Sale of the Griffith McConnell Residences property in Montreal PO

The General Secretary proposes that the Sub-Executive of the General Council:

1. Approve the sale by The United Church of Canada of Lot# 1053551 of the Cadastre of Québec, Registration Division of Montréal, together with all buildings erected thereon,

bearing civic address 5760-5790 Park Haven Avenue, in the City of Côte St-Luc, Province of Québec, the whole substantially in accordance with that certain Agreement of Purchase and Sale dated November 26, 2010, as amended, for a formal purchase price of not less than \$4,000,000 and aggregate proceeds of not less than \$7,700,000.

2. Authorize Robert Tabah or other such other United Church leader as may be named in writing by formal delegation of the General Secretary, to sign a Deed of Sale and such other accessory documents and agreements as may be required to effect the above-referenced transaction, with such minor amendments or adjustments as such signing authority may in her or his absolute discretion approve.

The General Secretary invited Erik Mathiesen to present the motion. Erik explained that this is protocol for property sales in Quebec. This is the eleventh amendment to this proposed sale. The likelihood of this closing next week is about fifty percent. Penalties of \$10,000.00 will accrue weekly until the closing of the sale.

Erik asked that Rosemary Lambie's name be added to the authorization list. The amended motion reads:
