Welcome

The Moderator Mardi Tindal welcomed the Sub-Executive of the General Council to the meeting with a check-in on how everybody is during this season of Lent.

The Moderator then opened with an excerpt from the Lenten study book.

Appointment of Chief Financial Officer

Nora Sanders mentioned that Erik Mathiesen has been acting in this appointment for the past number of months. Erik Mathiesen was chosen for this appointment after an advertised competition and interviews that included calls with the incoming Chair of the Finance Committee on the interview panel.

General Council Office Location Recommendation

Erik Mathiesen mentioned that Bill Kennedy will take the Sub-Executive of the General Council through the recommendation. In either proposal the existing lease at the 3250 Bloor Street West, will need to be extended by one to three years. Brian Cornelius and Heather Burton were present by conference call to hear the final proposals.

In summary the Bloor Street United church proposal:

- Is the more cost effective alternative.
- The office space is integrated within the church building itself and was uniquely designed for a partnership with General Council.
- The partnership is with the congregation directly rather than with the developer. The church would be the landlord.
- There is an opportunity to partner with a congregation in space sharing and design, allowing the office space to become a welcoming extension of the sacred space.
- The flexible design of the sanctuary would lend itself to larger gatherings.
- The entrance and entire building will communicate church identity and visibility, as well as being easier to navigate for visitors.
- A lease extension at our current location is required for either option and the extra time allows the church more time and flexibility to determine its needs.
- Proximity to Emmanuel College, the University of Toronto and a vibrant neighbourhood, home too many social justice organizations.
- We believe the Metropolitan project will find an anchor tenant and proceed in any case. Should acceptable lease terms with Bloor Street not be achieved, discussions with Metropolitan could be re-opened.
- Nora Sanders mentioned they haven't made the formal applications for city planning yet.
- Volunteer real estate experts felt the applications would be accepted by city planning.
- If the Bloor Street United church proposal is approved a presentation will go the Executive of the General Council meeting March 24 26, 2012.
